**GENERAL.** All correspondence should be addressed to: **The Editor, Caribbean Journal of Earth Science.**

Contributions must be original and should contain unpublished information and interpretations. Papers on all aspects of Earth Science in the Caribbean Region are welcome. Papers should not be currently submitted for publication elsewhere. Authors are solely responsible for the accuracy of their respective papers and for the correctness of their references. Each paper will be reviewed by at least two appropriate referees. The entire paper will become the property of the CARIBBEAN JOURNAL OF EARTH SCIENCE after it is published, subject to completion of a copyright agreement.

All papers should be written in English and must not exceed 10,000 words, including the abstract, references and figure captions. Priority will be given to short, concise papers. The Editor will carry out minor editing wherever appropriate to make a manuscript consistent with the style of the *CJES*. The manuscript will, however, be returned to the author where extensive alterations are required.

SI units should be used throughout and footnotes must be avoided.

Authors should consult a recent volume (**Volume 40** onwards) of the *CJES* to check details for style.

**SUBMISSIONS.** These should be sent as **MS Word files** (or compatible formats) by **email** to the **Editor** at:

It is advisable to send two, or more, emails to ensure that submission has been completed.

The first email should represent a 'covering letter'. An outline of the contents of the paper together with why it should be published should be included. The letter must state that the work is original and that the first author, together with any co-authors (or their Institution[s]), as applicable, hold the copyright of the work and agree to its publication. The email should also include a list of three suitable reviewers for the paper, together with

up-to-date contact information for them. Should there be potential reviewers that the author(s) regard as unsuitable, these may also be indicated. The paper should conclude with the list of files being submitted to the *CJES*.

The second, and any subsequent, email(s) should include the manuscript and any figures. Figures of suitable form for reproduction may be embedded (tif format for figures and jpeg format for photographs) at the end of the manuscript, or included in separate files.

**MANUSCRIPTS.** These should be word processed and double-spaced with a 2.5 cm margin on each side. A single electronic version of each file should be submitted by email. Authors are advised to keep a copy of the entire manuscript.

Minimize or avoid the use of non-standard characters. Type-setting may lead to these being deleted or replaced by other characters. Any use of non-standard characters should be checked carefully by the author on **Page Proofs**.

The text should be arranged as follows:

**Title** (12 pt, proper names with captitals, remainder as lower case)

**Authors** (12 pt., only capitalize first letter of names, leave rest as lower case)

**Addresses.** Addresses for each author (prefixed by <sup>1</sup>, <sup>2</sup>, etc.) and email for corresponding author.

**Abstract.** A concise abstract of typically less than 200 words.

**Keywords.** List up to five keywords or phrases.

There are two levels of numbering used by the *CJES*. First level is prefixed by a number (**1. Xxxx**) with a full stop and is centred. Please use Sentence case (Journal style will be followed during typesetting). The second level is two numbers (**1.1. Xxxx**) and is left justified. Appropriate titles to sections should be used relevant to what is standard in a discipline or following recent papers published in the *CJES*. Headings might include: **Introduction; Methods; Observations; Results;**

**Discussion; Summary; Conclusions.** A short, concise **Acknowledgements** section can be included.

**TABLES.** These can be included at the appropriate place in the text or at the end of the document. Tables can be set using the table function in **MS Word**, using a spreadsheet (e.g., **Excel**) or drafted in a drawing package and presented as an embedded tif file.

**FIGURES.** The position of Figures in the text should be indicated by inserting ‘**Insert Figure XX here**’ as a paragraph following the paragraph with the first citation to the figure in the text. Authors may highlight in bold their figure citations.

All illustrations, photographs, line diagrams and maps, are called Figures. These should be prepared in electronic format (hand drafted versions can be supplied for scanning of electronic preparation is not possible – but please consult the **Editor** first). Text on figures should be at a size where it can be easily read. Figures can be sent in tif format or jpeg format (photographs) or may be embedded at the end of the MS Word document containing the manuscript. If the files supplied are unsuitable for publication, revised copies may be requested. Illustrations at **column width (77 mm)** or **page width (160 mm)** are preferred. **Page length is 220 mm.** Linear scales, rather than magnification factors, should be used. Colour figures may be accepted for production of pdf versions of papers, but should be designed so that they can still be read in greyscale print runs.

**REFERENCES.** The literature cited in the text should appear in alphabetical order at the end of the paper. The author, date system should be followed and the titles of periodicals should NOT be abbreviated. In cases where reference is made in the text to a work by three or more authors, the first name followed by et al. is to be used throughout the text, but cited in full in the references. Total page

count should be given for formal reports. Examples follow:

**Bertrand, R. 1987.** A review of the Quaternary of Jamaica. In: **Ahmad, R. (Ed.),** *Proceedings of a workshop on the status of Jamaican geology. Special Publication of the Geological Society of Jamaica*, 331-335.

**Chubb, L.J. 1980.** The Wall collection of Cretaceous molluscs in the British Museum (Natural History). *Journal of the Geological Society of Jamaica*, **21**, 52-53.

**Geological Survey Department. 1954.** *Annual report for the financial year 1952-53.* Geological Survey Department, Kingston, Jamaica, 6 pp.

**Porter, A.R.D., Jackson, T.A. and Robinson, E. 1982.** *Minerals and Rocks of Jamaica.* Jamaica Publishing House, Kingston, 174 pp.

Authors may use bold and italics as indicated above, however, these will be redone when the paper is typeset.

**PAGE PROOFS.** Authors will receive a pdf of the paper prior to publication. Authors should check for errors in typesetting at this type, paying particular attention to non-standard symbols. Extensive revisions of the paper are generally not permitted at this time.

**OFFPRINTS.** The CJES no longer supplies offprints. A single high-quality copy of the final version of the paper will be sent to the corresponding author. This may be circulated in electronic format or paper format to individuals. The pdf should NOT be mounted on an open access website, unless permission is given by the **Geological Society of Jamaica.**

**PERMISSION TO REPRODUCE.** Please contact the *Editor* for permission to reproduced part, or the whole, of a paper published in the *CJES*, (or its earlier incarnations *Geonotes* and *The Journal of the Geological Society of Jamaica*).
