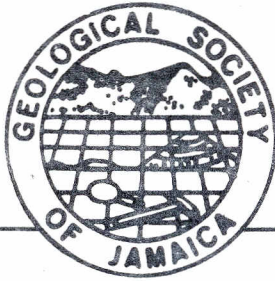

## NOTES FOR THE GUIDANCE OF AUTHORS

GENERAL: 1. Manuscripts (three copies) and correspondence should be addressed to the Editor, Journal of the Geological Society of Jamaica, c/o Department of Geology, University of the West Indies, Mona, Kingston 7, Jamaica, W.I.

2. Contributions must be original and should contain unpublished data and interpretations. Contributions should not have been submitted to any other journal for publication. Authors are solely responsible for the accuracy of their respective papers and for the correctness of their references. Each paper will be reviewed by two appropriate referees. The entire paper will become the property of the Journal after it is published, subject to the completion of a copyright agreement.

3. All papers should be written in English and must not exceed 10,000 words, including abstract, references and figure captions. Priority will be given to short and concise papers. The editorial staff will carry out minor editing wherever appropriate to make a manuscript consistent with the style of the Journal. The manuscript will, however, be returned to the author where extensive alterations are required. Authors will be sent page proofs.

4. Manuscripts should be typed, double spaced, on one side of paper measuring 21.5 x 28 cm ('A4', 'legal size') with a 2.5 cm margin on each side. An electric typewriter, IBM, Courier 10 ball is recommended. Three copies of text, figures, tables and captions should be submitted. Two of these will go to the referees and the originals retained by the editor. Authors are advised to keep a copy of the entire manuscript. The text of the manuscript may be supplied, in addition, on diskette(s) – 5.25-inch floppy diskette(s) with text in a form readable by an IBM personal computer: ASCII, DCA, Microsoft Word, Wordstar, Word Perfect, Writer, XyWrite, and MultiMate are acceptable.

TEXT: The text should be arranged in the following format: Title page, including abstract; main body of the paper – introduction, methods, observations and results, discussion, summary and conclusions, acknowledgements. The primary headings should be in centered capitals. Secondary headings may be used but these should be in underlined lower-case adjacent to the left-hand margin. The text should be paginated from title page onwards. The title page should carry a full title, the name(s) and address(es) of the author(s) and an abstract (200 words).

TABLES & FIGURES: Tables and figure captions should be typed double-spaced as separate lists and paginated. All illustrations, whether they are photographs, line diagrams or maps are called figures and in the text should be referred to as Figure if at start of a sentence or as Fig. otherwise. The authors should lightly pencil their names on the reverse of figures and use the left-hand margin of the text to indicate, in pencil, the desired location of figures. SI units should be used and footnotes must be avoided. As regards mathematics authors must provide clear instructions about how they wish symbols etc. to be set.

The Journal is able to print half-tone black and white photographs of good quality, but the use of photographs should be kept to a minimum. Drawings for text figures may be submitted either as original Indian ink drawings or as glossy photographic reproductions of such drawings. Indian ink drawings should be drafted on strong tracing paper, film or stout white paper. Good-quality photocopies are acceptable. Illustrations should not exceed 21.5 x 28 cm and an effort should be made to fit several figures on one sheet if they are smaller in size. Linear scales, rather than magnification factors, should be used on all figures requiring a statement of dimensions. Figures should be numbered with Arabic numerals in the order in which they are referred to in the text.

REFERENCES: The literature cited in the text should appear in alphabetical order at the end of the paper under the heading REFERENCES, which should be centered. The author (date) system should be followed and the titles of periodicals should not be abbreviated. In cases where reference is made in the text to a work by three or more authors, the first name followed by et al. is to be used throughout the text – e.g., Wadge et al. (1983) but cited in full in the references. Total page count should be given for internal reports, etc.. Examples follow:
